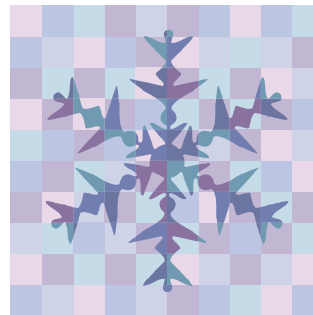

Eric L. Schleef

Mr. Schleef graduated with Honors from the University of Illinois College of Law in 2001. After graduation, he clerked in Central District of Illinois prior to being accepted into the Department of Justice Honors Program. In his five years with the Department of Justice's Antitrust Division, he participated in numerous criminal investigations into a variety of fraudulent and anti-competitive conduct, including recent efforts to prosecute fraud in connection with Department of Defense support services contracts in the Middle East. During the course of all of these investigations, he worked closely with other law enforcement and investigative agencies including U.S. Attorney's Offices, other Divisions of the Department of Justice, the FBI, DCIS, and numerous Inspector General Offices, and has represented the United States before both District and Appellate courts.

## **New AGA Chicago Chapter Stimulus Program**

### **CGFM Exams**

Interested in the CGFM certification? Sign up for AGA's special [Intensive Review Course](#) and take the CGFM Examinations after the NLC. Don't miss this opportunity to earn your CGFM.

The Intensive Review Course will take place from 8:30 a.m. – 5:30 p.m. on Monday, Feb. 22, and Tuesday, Feb. 23, 2010. The CGFM Examinations will be offered by appointment only on Feb. 24-25.

The cost of the course is only \$249 for qualified participants, and offers 18 CPE hours. Special Bonus: The CGFM Examinations are offered at no cost to course attendees. This is a special limited enrollment offer for those individuals who have already been studying for the CGFM Examinations and need extra reinforcement of the material. The Intensive Review Course is **not a substitute** for the three instructor-led training courses. On the contrary, it is designed as a supplement to previous preparation for the CGFM Examinations. Attending previous courses or studying using CGFM Study Guides before participating in this event is strongly encouraged.

*The cost of this course is not included in the NLC registration fee.*

### **Registration**

To participate in this event, individuals must:

- 1) Apply for the [CGFM Program](#) (submitting CGFM application form, fee and college transcript—see Eligibility section below).

The complete application for the CGFM Program must be submitted BEFORE or TOGETHER with the Intensive Review Course Registration Form. Registrations for this event will not be confirmed until after the CGFM application is accepted.

- **Deadline:** Registrations will be accepted on a first-come, first-served basis. Space is limited, so we encourage you to sign up early. Registrations will not be accepted after **Feb. 10, 2010**.
- *Cancellations must be received by Jan. 25, 2010; refunds will not be granted after this date.*

### **Eligibility**

To attend the Intensive Review Course and/or take the CGFM Examinations participants must first apply and be accepted into the CGFM Program. Candidates need to submit the CGFM Program application form with \$85 application fee and a copy of a transcript from an accredited college or university.

The transcript must show that a degree (bachelor's or higher) was awarded and list at least 24 credit hours of courses in financial management or related topics. Applicant's name and the name of the college or university must appear on all transcripts. Please see [www.agacgfm.org/cgfm/start/](http://www.agacgfm.org/cgfm/start/) for more information.

In addition, those individuals who want to complete their CGFM at this event need to submit a Work Verification Form listing at least two years of professional-level government financial management experience.

*Prior attendance of CGFM training course(s) or purchase of the CGFM Study Guides is not required, but is strongly encouraged.*

If you have already taken a CGFM Examination and did not pass, you must satisfy the waiting period before taking that CGFM Examination at this event.

### **OMB Sets Up Best Practices Website on Reducing Improper Payments**

The U.S. Office of Management and Budget (OMB) has established [Partner4Solutions.gov](http://Partner4Solutions.gov) to gather solutions and best practices to improve service delivery, payment accuracy, administrative efficiency, and reduce access barriers in federally funded assistance programs. States and local governments are already addressing these issues head-on and have identified many innovative approaches. Partner4Solutions.gov is an opportunity for taxpayers, program participants, and federal, state and local program administrators to provide their input and begin a dialogue to better understand some of the on-the-ground best practices in this area. This website is also a central element in meeting the transparency and collaboration principles of Executive Order 13520, "Reducing Improper Payments and Eliminating Waste in Federal Programs." ### **Economist: Stimulus Critical to Avoiding 'Draconian' State Government Cuts**

Mark Zandi, the chief economist for Moody's Economy.com, said Tuesday that additional federal stimulus dollars are crucial to helping state governments avoid Draconian spending cuts and tax increases in the difficult budget year ahead. Reacting to President Obama's call on Congress to boost aid to state and local governments, Zandi said if states do not receive additional federal money, it could slow the recovery, because states would have to cut spending and jobs and raise taxes. "If we're focused on creating jobs, state and local governments are one of the largest employers," he said. "It can't help the job market if we're cutting jobs." --Stephen C. Fehr, *Stateline.org*. ### **States and Localities Encouraged to Embrace New Openness Directive**

A directive from the U.S. Office of Management and Budget (OMB) released Tuesday orders federal government agencies to publish "high-value" data sets, launch Web sites for open government, and write agencywide plans that will hardwire transparency into the public process. Federal CIO Vivek Kundra and Federal Chief Technology Officer Aneesh Chopra unveiled the long-awaited Open Government Directive during a [live video chat](#) on [Whitehouse.gov](http://Whitehouse.gov). Chopra said the OMB "highly encourages" state and local governments to follow suit with similar transparency directives. "One of the things that we were so proud of when Vivek launched Data.gov was how many state and local governments replicated the model," Chopra said. "We see this as a key pillar of public-sector work—not just within the Obama administration. ... We think, we hope, this will be a helpful tool in support of state and local entrepreneurial activities to promote open government." AGA's Financial Management Standards Board (FMSB) has commented on two Governmental Accounting Standards Board (GASB) exposure drafts: a proposal to issue [Suggested Voluntary Guidelines on Reporting of SEA Performance Information](#); and a proposed statement on [Financial Instruments Omnibus](#).



The FMSB also commented on two Federal Accounting Standards Advisory Board (FASAB) exposure drafts on proposed Technical Releases giving implementation guidance on [Equipment Cleanup Costs and Cleanup Costs for Asbestos: Implementation Guidance on Asbestos Cleanup Costs Associated with Facilities](#) and [Installed Equipment and Implementation Guidance on Cleanup Costs Associated with Equipment](#).

### **Important Reminder for CGFMs Certified in 1994, 1995, 1997, 1999, 2001, 2003, 2005 or 2007**

We are almost at the end of the year--have you earned your 80 CPE hours?

If your CGFM certification was awarded in 1994, 1995, 1997, 1999, 2001, 2003, 2005 or 2007, you need to have at least 80 Continuing Professional Education (CPE) hours earned within the two-year period of **Jan. 1, 2008 - Dec. 31, 2009**. If short of the requirement, you can take advantage of the grace period of **Jan. 1 - March 31, 2010** to catch up on your CPEs. These hours cannot be counted toward your next cycle of 2010-2011.
